Applicable law and competent court

This *appointment letter* shall be governed by the terms of this *appointment letter*, the *European Community and European Union* acts related to FP7, the Financial Regulation applicable to the general budget and its implementing rules and other *European Community and European Union* law and, on a subsidiary basis, by the law of *Belgium*.

Furthermore, the *expert* is aware and agrees that the Commission may take a decision to impose pecuniary obligations, which shall be enforceable in accordance with Article 299 of the Treaty on the functioning of the *European Union*.



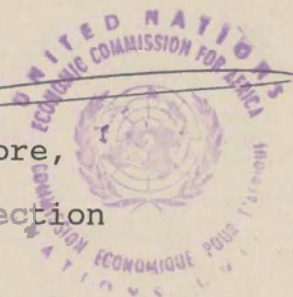
